- (1) **SAFETY:** Safe boating conduct must be observed all times by all tournament competitors. All contestants must wear a Coast Guard approved life vest when boat is on plane. All State, Coast Guard, Federal Parks & Wildlife regulations shall apply.
- (2) **TACKLE & EQUIPMENT:** Only artificial lures may be used. No live or prepared bait will be permitted except for pork strips, rinds, etc. No trolling with outboard motor is allowed. All fish must be caught in a legal sporting manner. Intentional snagging of fish will not be allowed.
- (3) **CITATIONS:** A contestant cited by officers for violation of State or Federal fishing or boating regulations during the tournament will be disqualified from the event.
- (4) **SPORTSMANSHIP:** All contestants are expected to follow high standards of sportsmanship, courtesy, safety, and conservation. Any angler who displays poor sportsmanship, violates these rules or any state or local laws or brings unfavorable publicity to the sport of bass fishing will be disqualified.
- (5) **ALCOHOLIC BEVERAGES AND DRUGS:** At no time during tournament hours are alcoholic beverages or drugs allowed.
- (6) **LIMITS:** Only largemouth, spotted and smallmouth bass can be weighed 15" and over. Each boat will be allowed to weigh in a five-bass limit.
- (7) **PENALTIES:** Any fish that does not measure will be penalized one pound plus loss of fish. Dead fish penalty will be 8oz. Over five fish limit penalty will be culling of largest fish until limit is reached.
- (8) **MEASURING:** Fish will be measured on golden rule and fanning of tail. No squeezing/pinching of tail.
- (9) **TOURNAMENT HOURS:** There will be 25 boats per flight. Start time is safe daylight: 1st flight weigh-in 2:00pm, 2nd 2:15pm, 3rd 2:30pm, 4th 2:45pm, 5th 3:00pm and so on. Boat # will be given in order of registration. You must sign this release form to participate. On water boat check as you blast off in order at the dock.
- (10) **Protest:** Any protest must be submitted in writing fifteen minutes after close of scales.
- (11) **Ties:** All ties in pay out spots will be divided equally between contestants.

- E) I signify by my signature that I have read, understand and agree to abide by all rules and regulations and decisions set forth by Freedom Marine Center LLC tournament officials.
- F) Freedom Marine Center LLC reserves the right to refuse participation in any event for any reason.
- G) Furthermore, I agree that all decisions made by the tournament director are final.
